AVIATION DIRECTOR MASCARO INFORMED THE AIRPORT ADVISORY COMMISSION ABOUT THE EFFORTS MADE BY SEVERAL AIRPORTS IN THE STATE OF ARIZONA, IN COORDINATION WITH THE CITY OF PHOENIX, TO SIGN A LETTER TO THE GOVERNOR. THE LETTER ADDRESSED THE NECESSITY OF KEEPING THE STATE AVIATION FUND WHOLE. THERE IS A CONCERN THAT THE STATE LEGISLATURE MAY "SWEEP" THE FUND FOR OTHER PRIORITIES NOT RELATED TO AVIATION PROJECTS.
